Wafa Ben-Hassine
Principal, Responsible Technology, Omidyar Network

Wafa Ben-Hassine is a principal on the Responsible Technology team at Omidyar Network, where she leads the organization's vision and portfolio on Digital Trust and Safety and is a member of the Generative AI team. Prior to joining Omidyar Network, Wafa served as a consultant at the International Finance Corporation (IFC), where she managed an open innovation challenge to advance the IFC's financial inclusion agenda. Previously, she was the Middle East and North Africa policy manager and Global Policy Counsel for Access Now, a global non-profit organization defending human rights online. Wafa also consulted for the United Nations Office of the High Commissioner for Human Rights (OHCHR), and the United Nations

Educational, Scientific, and Cultural Organization (UNESCO). Wafa is a Term Member of the Council on Foreign Relations. She has served as the co-chair of the World Economic Forum's Global Future Council (GFC) on Human Rights and the Fourth Industrial Revolution, and as a member of the GFC on Data Policy. She serves on several other committees, boards, and task forces that are focused on how society interacts with emerging technologies, such as the Partnership on Artificial Intelligence's Safety-Critical AI Steering Committee. In 2011, Wafa served as Tunisia's first-ever legislative aide in the national Constituent Assembly, helping to encode human rights into the text of the constitution. She was also the Editor-in-Chief of Tunisia Live, an independent English language news network, and a columnist at Nawaat, a blogging collective. Wafa holds a JD from the University of Denver, Sturm College of Law, and a BA in political science, public law from the University of California, San Diego, where she served as student body president. She is a licensed attorney with the state of New York and is based in Washington, D.C.
